3.9. MotoData uses cookies on this website. Cookies are small, risk-free text files which are stored on your computer's hard drive when you visit most websites. These files hold small amounts of data and allow the server to recognize you when you revisit a website.

MotoData uses both session and persistent cookies.

A session cookie (also called a transient cookie) is temporary and will be erased once you close your browser.
